Driver Times - A Compliance service in Volvo Connect

Volvo Connect is one single interface for your fleet and business where you can manage vehicles, trailers and all other assets of importance.

Compliance with the EU legislation on driving time and rest periods

With the Driver Times service, it is easy to stay compliant with the EU legislation on driving time and rest periods and the road transport Working Time Directive. The driving time as well as the remaining time until required break or rests are presented to drivers and transport planners, allowing them to stay compliant and maximize the utilization of drivers' hours.

- Automated daily remote download of tachograph memory and driver card data files.
- Graphical presentation of driver activities.
- Continuously estimates the remaining driving and working times. It also presents the most optimal driver and vehicle for the next mission.
- Driver activity reports provide a basis for invoicing and calculation of driver wages.
- Analyse and document infringements according to EU regulations.
- View your tachograph and driver data coverage to be prepared for audits.
- Company Card Hosting* enables tachograph download at all times.

DRIVER TIMES**Optimize planning of drivers and avoid infringements**

To support efficient transport planning, the Driver Times service in Volvo Connect instantly shows how much time each driver can spend on new assignments. Also, drivers can at any time view their driving, working and rest times in the Volvo Connect app on smartphones.

Infringements reports based on the EU legislation on driving time and rest periods and the road transport Working Time Directive facilitate the analysis and provides notifications in advance to avoid potential fines.

The service includes support for double manning crews and regulations.

Manage compliance together with your drivers

Driver Times includes an intuitive solution to view and manage the follow-up of infringements together with your drivers. View and print infringements and their estimated penalty, document the comments of the driver and finally archive in a safe storage.

Drivers can in the Volvo Connect app view their infringements, comment them and upload supporting documents to simplify your compliance handling.

Remote tachograph download

Driver Times automates the daily download of tachograph memory data and digital driver card data from the truck. All files are securely stored and available in Volvo Connect. Files can also be automatically exported to your preferred tachograph post-processing software.

At certain Volvo dealers, Company Card Hosting is available as an additional service.

Driver Times Support for the driver

The Driver Times Support* feature in the side display in the vehicle coaches the driver to comply with the EU legislation on driving time and rest periods. It warns the driver to mitigate infringements and also provides detailed information on the remaining driving time.

Driver Times Support* in combination with the Driver Times service allow the driver to initiate tachograph and driver card download as well as report their driver activities to Volvo Connect.

* Driver Times Support is standard in a Volvo FH, FM and FMX manufactured after week 9 in 2021. For Driver Times Support to be available in a Volvo FH, FM and FMX manufactured before week 9 in 2021, a side display and an active Driver Times subscription is required.

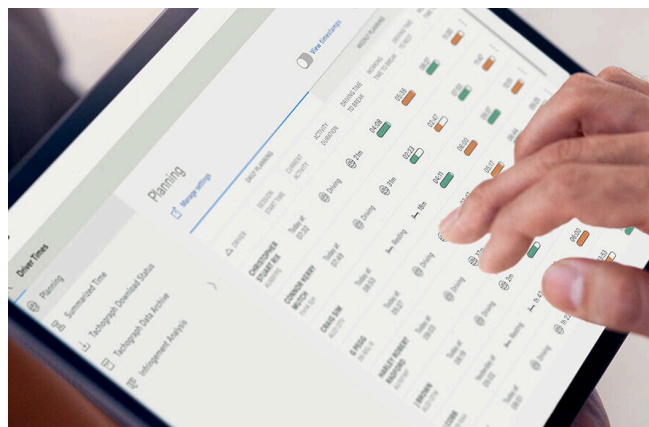
