Trust Volvo to provide the warranty cover that makes the difference

†Fitted-Parts Warranty is only available on replacement parts fitted in Great Britain and Ireland, and is not available on parts purchased overseas. In the event of a failure overseas that is covered by the terms of Fitted-Parts Warranty, the repair must be carried out by an authorised Volvo Workshop, and any claim for reimbursement of warrantable costs can be made through an authorised UK/RoI Volvo Authorised Workshop (full repair details and invoice must be provided, as well as proof of original purchase). Replacement Parts supplied and/or fitted overseas benefit from the Standard Warranty in the UK and Republic of Ireland.

For engines; a condition of the 3 year major unit Fitted-Parts Warranty described is that the repairing Volvo Workshop must be satisfied with the condition of the radiator and compressor, and that the customer agrees to their replacement where necessary.

Notes Proof of purchase must be presented in the event of any Warranty claim. Material replaced under Standard Warranty or Fitted-Parts Warranty automatically becomes the property of Volvo Group UK Ltd. This summary of the Genuine Volvo Parts Warranty and Extended Product Cover in Great Britain and Ireland does not constitute a legal definition of the offer. Volvo Group UK Ltd. reserve the right to update the warranty and product cover terms from time to time, latest terms and conditions are available from Volvo Group UK Ltd., Wedgnoek Lane, Warwick, CV34 5YA. The warranty terms that apply are always those ruling at the time of purchase. Warranty claims are only accepted in the case of a warrantable defect and not for fair wear and tear whatever the mileage. This applies particularly to filters, friction materials and consumables where heavy use may bring the normal lifetime within the warranty period.

Genuine Volvo Parts are those parts which are supplied under the Volvo brand by Volvo Group UK Ltd. to its Authorised Workshops in Great Britain and Ireland. All other parts supplied by a Volvo Authorised Workshop (including Roadcrew parts) are not subject to the above warranties. Customers are advised to confirm precise warranty terms and conditions on such parts prior to purchase.

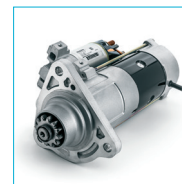

Have the part fitted by a Qualified Technician and the warranty is automatically extended to 24 months (unlimited) for both parts and labour and should a part failure cause a breakdown or be of a safety nature, Volvo will cover the costs of call out and recovery if necessary.

But that's not all; major component parts such as engines and gearboxes, enjoy the benefit of a 3 year (unlimited) warranty when fitted by a Qualified Technician.



STANDARD WARRANTY – 12 MONTHS* (Unlimited mileage)

On all Genuine Volvo Parts supplied should a Genuine Volvo Part fail because of a warrantable defect.

FITTED-PARTS WARRANTY – 24 MONTHS* (Unlimited mileage)

On Genuine Volvo Parts supplied and fitted by a Qualified Technician.

FITTED-PARTS WARRANTY – 36 MONTHS* (Unlimited mileage)

On engines, gearboxes and differentials supplied and fitted by a Qualified Technician.
